DETERMINATION OF NONSIGNIFICANCE

Description of proposal:

This rule adds a definition of "conversion activities" to WAC 222-16-010 to help field staff recognize activities common to converting lands from forestry to non-forestry uses.

Context: This is a Forest Practices rule proposal that contributes to the implementation of 2007 legislation, Second Substitute Senate Bill 5883 (SSSB 5883) regarding conversion of forest lands to non-forestry uses. In part, SSSB 5883:

- Eliminated the six-year development moratorium that applies to a landowner who indicates on a forest
 practices application or notification form (FPA/N) the intent not to convert to a non-forestry use; and
- Eliminated the requirement for forest landowners to file a development moratorium form with an FPA/N.

Pursuant to this legislation, if a Department of Natural Resources or local government field practitioner observes activities that indicate conversion to a non-forestry land use, a notice must be sent to the local governmental entity and the Department of Ecology (DOE).

Eliminating the requirement to file a development moratorium form with an FPA/N, increases field staff responsibility to notify DOE and local governmental entities when unreported conversion activities are taking place. As stated above, the rule proposal is intended to help field staff recognize activities common to converting lands from forestry to non-forestry land uses.

"Conversion activities" means activities associated with conversions of forest land to a land use other than commercial timber operation. These activities may be occurring concurrently or after timber harvest on forest land and may include but are not limited to the following:

- Preparation for, or installation of, utilities, except on easements providing utilities to other ownerships.
- Grading and filling.
- Preparation for, or construction of, any structure for which a landowner would be required to obtain local government approval.
- Construction of, or improvement of, roads to local governmental entity standards.
- Clearing for, or expansion of, a borrow pit for non-forest practices uses or to make a surface mine.
