Teanaway Community Forest Recreation Plan Guidelines

Teanaway Community Forest recreation goal

To maintain and where possible expand recreational opportunities consistent with watershed protection, for activities such as hiking, fishing, hunting, horseback riding, camping, birding, and snowmobiling.

DNR's recreation vision

Provide diverse and high quality recreational opportunities on DNR landscapes that foster community engagement, promote a strong sense of environmental stewardship, and enrich the quality of life in Washington.

Recreation planning mission

- To provide insight and input to help DNR/WDFW make decisions related to recreation management.
- To work with the planning team staff to develop draft recreation management recommendations.
- The recommendations must:
 - o Recognize that the planning area is a Community Forest which is a part of a larger regional landscape.
 - o Be consistent with watershed protection and the other principles of the Teanaway Community Forest.
 - o Build upon the objectives and strategies already established in the Teanaway Community Forest Management Plan.
 - o Coordinate planning with adjacent lands to identify opportunities for connections across a larger planning area.

Advisory Committee commitments

- Commit to attend and actively participate in all meetings throughout the process, including presenting the committee's recommendations to the public.
- Meet with other interests not directly represented within the committee to share ideas and solicit input.
- Agree to focus on the whole community by considering the interests of recreation activities or organization(s) other than your own, in addition to giving input related to your recreational area of interest
- Agree to work within these guidelines set forth by DNR/WDFW and the ground rules agreed upon by the group.
- Be creative and forward thinking; while recognizing that the future is uncertain and technology, information, markets, or other situations may develop that provide new opportunities for recreating in the community forest over time.

Time commitment required

- Approximately 12 to 14 meetings three hours in length.
- Review the materials provided prior to each meeting.

- Participate in two to four field trips.
- Attend up to four public meetings and community workshops.

The Teanaway Community Forest Advisory Committee is currently expected to meet for recreation planning from January 2017 to fall 2018 with the following draft schedule:

- The first meeting is Thursday, January 12th
- 12 to 14 recreation planning committee meetings
- Spring/summer for field trips (three to four)
- Up to three community open house meetings
- Review final concept plan fall 2018

Teanaway Advisory Committee's role in recreation planning

The Teanaway Community Forest Advisory Committee is developing draft recreation management recommendations and providing information and insight to DNR/WDFW staff for the development of the Teanaway Community Forest Recreation Plan.

Draft recommendations developed in this committee will be presented to DNR/WDFW decision makers: DNR Southeast Region Manager, WDFW Region 3 Director, DNR Conservation, Recreation and Transactions Division Manager, and Executive Management.
