The proponent, a resident of Kelso, states that "'Lapóme' [sic] is of Chinook Wawa [Chinook Jargon] meaning 'apple'" and that the name references the history, culture, and agriculture of the Smokey Valley area which "has historical significance of the Cowlitz Indian Tribe."

The creek runs through a developing apple orchard, and the property owner's last name is Applebury.

Case Summary

The new name <u>Lapome Creek</u> is proposed for an unnamed 0.7-mile-long tributary of Pin Creek in Lewis County.

The proponent, a resident of Kelso, states that "'Lapóme' [sic] is of Chinook Wawa [Chinook Jargon] meaning 'apple'" and that the name references the history, culture, and agriculture of the Smokey Valley area which "has historical significance of the Cowlitz Indian Tribe." She also reports that an individual with the last name Applebury is developing an apple orchard along the stream and that "[w]ith personal land use significance to the ranch owner as well as the

opportunity to honor a cultural and historical area of an American landscape, we propose this name in respect to documentation and preservation of the geographical area."

The proponent provided a link to <u>an entry for "apple"</u> in the online Cowlitz Coast Salish Dictionary, which notes that the word that means apple is lipúm and that it is a loanword that comes from the "Chinook Jargon Iapóme 'apple', taken in turn from French le pomme 'apple."

George Gibbs' 1863 *A Dictionary of the Chinook Jargon* records the following in the Chinook—English section (capitalization modified and syllable-marking hyphens removed):

- lapóme, n. French, la pomme. An apple. (but "apple, le pome" in the English—Chinook section)
- powitsh, n. Chinook, pauitsh. A crab-apple

C. M. Tate's 1914 *Chinook Jargon as Spoken by the Indians of the Pacific Coast* records the following in the English-Chinook section:

- apple, le pom. (but no entry in the Chinook-English section)
- crab apple, powitch

A 1990 article by J. V. Powell in the *International Journal of American Linguistics* titled "Chinook Jargon Vocabulary and the Lexicographers" reports that the term "lapome" is only found in one Chinook Jargon dictionary; the article mistakenly cites this from John Good's 1880 *A Vocabulary and Outline of Nilakapamuk or Thompson Tongue Together with a Phonetic Chinook Dictionary Adapted for Use in the Province of British Columbia*, which does not contain the word "lapome."

BGN staff asked the proponent if the word should be Lapome or Lapóme but to date no response has been received.

The hydrology recorded in the USGS National Hydrography Dataset conflicts with that of the Washington Department of Natural Resources. BGN staff asked the proponent to clarify the extent of the stream but again has not responded.





Dear Ms. Whalen:

This acknowledges your proposal to the U.S. Board on Geographic Names (BGN) to apply the new name <u>Lapome Creek</u> to an unnamed stream in Lewis County.

The BGN is responsible for standardizing geographic names for use by the Federal Government, and its members must approve any new name before it can appear on Federal maps and products. We will prepare a case brief for the proposed name and add it to the BGN's next Quarterly Review List. In order to complete the brief, we need clarification on a few items:

- --- Regarding the extent of the stream, is the attached map (blue line) correct? Does the stream flow into Pin Creek, or into an unnamed tributary of Pin Creek? The map on the left shows that according to the BGN's database (Geographic Names Information System, i.e., GNIS), the current source (headwater) of Pin Creek is further north and does not extend to any of the tributaries. The National Hydrography Dataset and the Washington Department of Natural Resources show the source slightly to the south, but again, not along any of the tributaries. (Please note that the location of Pin Creek does not have a direct bearing on the proposal for <u>Lapome Creek</u>, but if you have any local knowledge that is always appreciated. We will also ask the DNR for their advice and if necessary, make any changes to the database.)
- --- For the source (headwater) of the proposed name, we will go with the middle of the three tributaries, as highlighted in blue and shown on your Dept. of Ecology map (even though the more easterly one is slightly longer, and which is normal BGN policy).
- --- Although the proposal does not state that it specifically honors the ranch owner, the BGN may be concerned that the name Applebury could violate the Commemorative Names Policy. That is, no new name can honor or be construed to honor a living person. The intended honoree must have been deceased at least five years and should have had a long-term association with the geographic feature or made a significant contribution to the community. To confirm, the name simply refers to the production of apples and not to the property owner?
- --- The BGN also has a Commercial Names Policy. Can you confirm that the orchard is not named "Lapome", i.e., there is no use of that name in a business or commercial product?
- --- What is your connection to the orchard and/or the Applebury family? Is the ranch owner aware of your application?
- --- Looking at the online Cowlitz Coast Salish Dictionary (which notes that the Salish word for apple is lipúm), the Chinook Jargon word is recorded as "lapóme". Did you intend to include the accent mark in the name?

Indeed, because the proposed name is derived from a Native language, the BGN is asking that you review its guidance entitled "Cultural Sensitivity for Native American Names" at https://www.usgs.gov/us-board-on-geographic-names/cultural-sensitivity-native-american-names. This document requests that the proponent of any name that would be of interest to a Tribe make an effort to seek the opinion of a Tribal government(s) and/or a linguist or cultural authority regarding the appropriateness of the chosen name. In this case, that would likely be the Cowlitz Indian Tribe or an authority on Chinook Jargon. A lack of Tribal input does not necessarily prevent the BGN from approving the proposal, but if no effort is made to seek their

input, it could impact the final outcome. The guidance includes a link to the Bureau of Indian

Affairs Tribal Leaders Directory. Any Tribal comments can be submitted to BGNEXEC@usgs.gov. Local opinion is important to the BGN, so once have responses to our questions, we will forward your application to the WGNC). As part of its review, the WGNC will seek the opinion of the county government and any State agencies that might wish to comment. We will also ask all federally recognized Indian Tribes if they wish to comment. If you can gather additional support from local residents or a local historical society, we would welcome that for the file. The secretary of the WGNC may wish to contact you to discuss your application.

Once all parties have had an opportunity to provide their recommendations, we will present the proposal for <u>Lapome Creek</u> (or <u>Lapome Creek</u>?) to the BGN for discussion and the final decision. The entire process typically takes several months, but we will notify you of the outcome. Thank you for your interest in the geographic names of Washington and we look forward to hearing from you. Please let us know if you have any questions.
