Cooperative Monitoring Effectiveness and Monitoring Extensive Monitoring Workshop Presenters Information

What is the format for the presentations?

- The introduction, background and strategy portions will review what has been done to date.
- Speakers will be given a list of the 13 example questions developed by RSAG and CMER for Timber Fish and Wildlife (TFW) Policy that are included in the CMER Extensive Monitoring Strategy. The questions will be prioritized or added to by TFW Policy. The speakers will be asked to discuss how their work would or would not inform the questions.
- If the speakers feel that there are any additional questions or issues that will inform the topic, they are encouraged to bring their thoughts to the discussion.
- The afternoon session will be devoted to a round table discussion with presenters and the audience.
- Conclusions could be summarized after the discussion and recorded for distribution to participants.

What is the purpose of the workshop?

• The purpose of the workshop is to help policy makers understand the importance, value, and limitations of extensive monitoring. Cost and benefits will also be discussed.

What is the objective of the workshop?

• The objective of the workshop is to encourage TFW Policy to make decisions that will inform the CMER strategy for extensive monitoring they received in 2019.
