





If an active Northern Goshawk nest is found within a 0.55 mile radius of timber sale associated activities will be restricted between February 1 and August 31.
- 3. The construction of the CM-ML and CW-38 is on an abandoned grade. Construction of the CW-3807 and CW-48 is on an orphan grade.


