Reopening Reiter Foothills Forest: What will it take?

In April 2010, the Department of Natural Resources (DNR) completed work on the *Reiter Foothills Forest Recreation Plan* and the plan's review through the State Environmental Policy Act (SEPA). Since November 2009, DNR staff and volunteers have been restoring environmental damage and stabilizing stream banks, as well as designing and developing new trail systems in the area.

Goal for Reiter Foothills Forest: To provide a variety of fun, challenging, safe, and sustainable recreational opportunities while responsibly managing the state's trust land assets and natural resources.

DNR may reopen Reiter Foothills Forest in several phases, starting with areas that need few, if any, permits or other regulatory requirements.

Q. What areas can DNR open without needing permits, site-specific SEPA review and approval, or other requirements?

A. DNR-managed forest roads in the area can be opened to recreation without needing permits. The area is currently open to dispersed foot traffic, including hunting and fishing.

Q. What can DNR open once the *Reiter Foothills Forest Recreation Plan* and the SEPA review on the plan is completed and will not require county permits or site-specific SEPA?

A. We can reopen the sections of authorized trails that cross onto DNR lands, such as those from Wallace Falls State Park, provided we establish a formal agreement with adjacent landowners.

Q. Which trails and facilities require county permits, site-specific SEPA, and/or other regulatory requirements?

A. The following table lists what's typically required to develop trails and trailheads.



Q. What else needs to be in place before DNR can open trails in Reiter Foothills Forest?

A. Items that will need to be in place include:

- Developed trails and established trailhead and parking areas.
- An education and enforcement strategy involving DNR staff, the volunteer forest watch program, and partnerships with other agencies.
- A maintenance strategy for trails and facilities involving DNR staff and volunteers.
- A monitoring plan to address unlawful behavior and natural resource protection, including water quality.

Securing funding and resources will be critical to accomplishing these tasks.
