Copper Swan Timber Sale #106142 and Forest Practice Application #3026861 is a sale of approximately 2,500 MBF of timber on 270 acres. The proposal includes 2,131 feet of road construction, and 44,758 feet of road maintenance. Located in Sections 04, 05, 16, 20, 27, 33, Township 36 North, Range 32 East, W.M., Ferry County.
