Mr. Shay agreed that this was an abnormal 4th quarter in regards to prices and amount of volume 1 offered (lower volume). In the upcoming fiscal year, the Department plans to offer less volume 2 in the 4th quarter, by moving more volume into the more profitable 2nd and 3rd quarters. Mr. Shay 3 added that the 1st quarter of fiscal year 2018 is to have less volume than the previous fiscal year 4 by moving sales in to the more profitable 2nd and 3rd quarters. Mr. Shay also noted there have 5 been no discernible effects of the tariff on Canadian timber. 6 7 8 Mr. Shay then presented proposed sales for August and September 2017 to the Board 9 10 Mr. Shay asked the Board for questions. There were none. 11 Mr. Shay asked for approval of the proposed sales as presented. 12 13 Commissioner Peach moved to approve the proposed sales. 14 MOTION: 15 Superintendent Reykdal seconded the motion. 16 SECOND: 17 18 ACTION: The motion was approved unanimously. 19 20 PUBLIC COMMENTS FOR LAND TRANSACTION ACTION ITEMS 21 22 LAND TRANSACTION (Action Item) Amendment to Resolution 1500 23 Michelle Burbidge, Conservation, Recreation and Transactions 24 Michelle Burbidge spoke to an amendment to Resolution 1500, approved in April 2017, due to 25 an administrative error. 26 27 28 Ms. Burbidge asked for approval of Amendment 1500 29 30 MOTION: Commissioner Peach moved to approve Amendment to Resolution 1500. 31 Superintendent Reykdal seconded the motion. 32 SECOND: 33 34 ACTION: The motion was approved unanimously. 35 PUBLIC COMMENTS FOR CHAIR REPORT 36 37 Randy Johnson, Clallam County Commissioner, spoke about DNR arrearage. He shared

38 39 statistics, shared at a county forum, with the Board on how many are in poverty in Clallam County. He asked the Board to keep in mind the impact to Clallam County while other counties 40 41 are better off.

- 42 Ed Bowen, Clallam County Citizen, spoke about arrearage and the impacts to junior taxing 43 districts, adding that veterans are dependent on the timber revenue and he asked the Board to
- resolve the arrearage issue. 44
- Patricia Jones, OFCO Representative, spoke about concerns with the mitigation of take for the 45
- marbled murrelet and that it under-represents the take. She asked the Board to keep in mind their 46
- conservation alternative. 47

Mr. Brodie began the presentation with a history of past Board presentation topics and where this month fits into the timeline of choosing a preferred alternative. He spoke specifically about the Board retreat in August, including the field tour and the components of that tour. He added that day 2 would be about exploring the components of a preferred alternative at a half-day meeting, and that the Board would then select the preferred alternative in September.

Mr. Hayes then followed up on questions asked by the Board in June. First, he exhibited the Story Map online tool to show members a feature that allows easy comparison between maps of murrelet alternatives. Second, Mr. Hayes described the reasoning in using different survival rates in the pseudo-PVA analysis and third, he shared a breakdown of murrelet survey effort by land ownership noting that over half of the state's survey stations are on DNR-managed land.

In relation to the pseudo-PVA analysis, Dean Mittelhammer asked to what extend do we feel that DNR actions would move adult survivorship from .87 to .90, and on which DNR-managed lands could we have an impact. Mr. Brodie replied that the DNR could have influence where there is marine rich water.

Chair Franz spoke about the risk on timing, asking what the level of impact is on the species when the graphs for risk/enhancement scenarios fall below the baseline (focusing on years 10-20). Mr. Brodie stated that staff will come back to the Board at the next meeting to answer that question. He then shared concerns that modeled population impacts within that timeframe might be too risky.

The next set of slides showed tables with net present value (NPV) for each option combination. Each trust and county were also evaluated for each sustainable harvest calculation component (murrelet, arrearage, and riparian) by characterizing their maximum range of change to NPV. He shared the percentage range of change for trusts and counties, highlighting trusts and counties that are most influenced by specific components. The murrelet component had the greatest impact, but it varied by trust and county. He then presented the area in production and management costs in a similar format.

Mr. Hayes began the next section on public comments by discussing the overarching themes around each decision component: arrearage, riparian, and murrelet. Those largely dealt with preferences for either more or less conservation or volume, as well as recreation and specific geographic interests. Mr. Hayes reminded the Board of the criteria to consider in choosing a preferred alternative.

Discussion took place on long- and short-term impacts of the arrearage options, as there were impacts to timber harvest flow, highlighting that variability of harvest volume within the planning decade caused by arrearage may also have an impact on staffing.

Mr. Hayes discussed the alternatives for marbled murrelets proposed in public comments. The components that comprise each of the six alternatives were described, and then impact/mitigation and murrelet specific conservation acres were shown for each against the DEIS alternatives. Using LTFC acres and a regression of the DEIS options, 10-decade NPV was also projected for each proposed alternative. In general, WDFW and EPA-E alternatives fell within the range of the

47 DEIS alternatives, while the others contained significantly more conservation.
