* First Come, First Serve Basis

* Keep all ditches, roads \& landing free of debris.
* Be careful of newly planted seedlings.
* No cutting live trees, standing snags, or blue painted trees
- Mechanical yarding NOT permitted.

ADDITIONAL CONDITIONS FOR
FIRE SEASON
(April 15 to October 15)
Power saw operators must have a:

* Shovel and fire extinguisher on-site AND an approved spark arrester on $\mathbf{A L L}$ chain saws.
* Cutting allowed on PRECAUTION LEVEL 1 days only.
* Fire extinguisher must be minimum $21 / 2$ pounds.
* A fire watch is required for one hour following shut-down of chain saws

## DRIVING DIRECTIONS - LINCOLN CREEK FIREWOOD PERMIT

## From Chehalis

From I-5, take exit 77 in Chehalis and head west on Highway 6 for 17 miles.
Turn right onto Chandler Rd and follow for 2 miles to reach the L-3000 road.

## UNITS 1, $2 \& 3$

Turn right onto L-3000
Unit 1: Follow L-3000 for 3.6 miles to reach Unit 1.
Unit 2: Follow L-3000 for 3.9 miles to reach Unit 2.
Unit 3: Follow the L-3000 for 4.2 miles and turn right onto L-3025. Continue 0.75 miles to Unit 3 .

UNITS 4, 5, $\mathbf{6}$ \& $\mathbf{7}$
Turn right onto L-3000 and follow for 6.2 miles to L-3043 and Unit 4.
Unit 5: From the intersection of L-3000 and L-3043, turn right onto L-3043 and continue for 0.5 miles to Unit 5 .

Unit 6: From the intersection of L-3000 and L-3043, continue 0.9 miles to Unit 6.
Unit 7: From the intersection of L-3000 and L-3043, continue 0.9 miles and turn left onto L-3042. Continue 1.1 miles to Unit 7.

## DRIVING DIRECTIONS - LINCOLN CREEK FIREWOOD PERMIT

## From Centralia

From I-5, take exit 82 in Centralia and head west on Harrison Ave. for 0.8 miles.
Turn left on Galvin Rd. and follow for 1.9 miles until Galvin Rd. becomes Lincoln Creek Rd., then follow Lincoln Creek Rd an additional 11.9 miles to the intersection with Lepisto Rd.

## UNITS 8 \& 9

Turn right onto Lepisto Rd and continue for 1.4 miles to the L-2000 Gate. Follow the L-2000 2.6 miles to the L-2020.

Unit 8: Turn right onto the L-2020 for Unit 8.
Unit 9: From the L-2000 and L-2020 intersection, follow the L-2020 for 0.25 miles to reach Unit 9 .

## UNITS 4, 5, 6 \& $\mathbf{7}$

From the Lepisto Rd and Lincoln Creek Rd intersection, continue on Lincoln
Creek Rd for 1.3 miles, then turn right onto the L-3000.
Unit 6: Follow the L-3000 for 4.5 miles to Unit 6.
Unit 7: Follow the L-3000 6 miles, then turn right onto the L-3042. Follow the L30421.1 miles to reach Unit 7.

Unit 4: Follow the L-3000 6.25 to reach Unit 4.
Unit 5: Follow the L-3000 6.9 miles and turn left onto L-3043 and follow for 0.5 miles to Unit 5.

## UNITS 1, $\mathbf{2}$ \& $\mathbf{3}$

From the Lepisto Rd and Lincoln Creek Rd intersection, continue on Lincoln
Creek Rd for 1.3 miles, then turn right onto the L-3000.
Unit 1: Follow the L-3000 for 7.7 miles to the L-3100 and Unit 1.
Unit 3: Follow the L-3000 for 8.9 miles. Turn left onto L-3025 and follow for 0.75 miles to Unit 3.

Unit 2: Follow the L-3000 for 9.2 miles to Unit 2.
