SUBJECT: DRAFT ENVIRONMENTAL IMPACT STATEMENT ON THE LONG-TERM CONSERVATION

STRATEGY FOR THE MARBLED MURRELET

The proposal is to amend the Department of Natural Resources 1997 State Trust Lands Habitat Conservation Plan (State Trust Lands HCP) to include a long-term conservation strategy for the marbled murrelet. This is a joint draft environmental impact statement between U.S. Fish and Wildlife Service (USFWS) and the Department of Natural Resources to satisfy both the National Environmental Policy Act and the State Environmental Policy Act. This proposal was not included at the time of adoption of the State Trust Lands HCP because the plan provided only an interim conservation strategy for the marbled murrelet. The interim strategy was to remain in place until more scientific information could be collected on habitat on state lands and the marbled murrelet's biological needs to make the development of a long-term conservation strategy possible. At this stage in planning, the proposal for a long-term conservation strategy is described as a set of six alternatives, including a no action alternative. The alternatives represent a range of approaches to long-term marbled murrelet habitat conservation on DNR-managed lands within 55 miles of marine waters. The development of these alternatives was guided by a need, purpose and objectives approved by the Board of Natural Resources (the Board) and U.S. Fish and Wildlife Service (USFWS). The no action alternative reflects what would occur if DNR did not adopt a long-term marbled murrelet conservation strategy. The location for this proposal is in the six Westside Planning Units (land in range of the marbled murrelet in Clallam, Cowlitz, Gravs Harbor, Island, Jefferson, King, Kitsap, Lewis, Mason, Pacific, Pierce, San Juan, Skagit, Snohomish, Thurston, Wahkiakum, and Whatcom Counties) of DNR's Trust Lands Habitat Conservation Plan.
