This is to advise you that pursuant to WAC 197-11-900 (922 through 948), the Department of Natural Resources has determined that it is Lead Agency for the following:

Jackson Timber Sale #98225 and Forest Practice Application #3023371 is a sale of approximately 5,000 MBF of timber on 210 acres. The proposal includes 12,843 feet of road construction, and 10,936 feet of road maintenance. Located in Section 06, Township 28 North, Range 45 East, and Sections 31, 32, Township 29 North, Range 45 East, W.M., Spokane County.
