3950 feet of road construction and 84 acres of clear cut timber harvest. A number of Rule Identified Landforms are found throughout the project area. Most have been excluded from the timber harvest. However a few have been left within the bounds of the harvest unit. Class IV special triggers within the unit include sites LS-1 through LS-5 as well as their associated groundwater recharge areas from the attached Geotech report.

LS-4 and LS-5 are glacially deep-seated landslides noted in the landslide inventory. LS-1 through LS-3 were found on LiDAR and investigated in the field. The portions of LS-1 through LS-5 that are included within the proposed harvest unit support straight growing conifers and in-place old growth stumps and show evidence of movement after previous forest practices.
