CD I have reviewed this SEPA Checklist and have the following comments:

A. Background

7. No additional permits needed from Grays Harbor County if stumps are not removed (per GHC Planning & Building Division email 8-13-2020).
11. FPA/N 2616623 indicates approximately 5.16 acres of even-aged harvest with an estimated 71 MBF of timber being removed using rubber tired skidder in one harvest unit. This is a Class IV-General (conversion) forest practice application.
12. The location of this proposal is confirmed as Section 12 Township 19, Range 9 West in Grays Harbor County, per Question 7 of FPA/N 2616623. The project is located in Grays Harbor County tax parcel number 190912310050.
