This is to advise you that pursuant to WAC 197-11-900 (922 through 948), the Department of Natural Resources has determined that it is Lead Agency for the following:

Forest Practice Application #2616687 proposal is an even-aged harvest of approximately 10 acres in two harvest units, with approximately 300 MBF of timber being removed using shovel, dozer, and skidder harvesting methods. The proposal includes one F crossing (bridge) and approximately 1,000 feet of road construction. Due to conversion of land to non-forestry use, the proposal is a Class IV General. Located in Section 05, Township 29 North, Range 05 West, W.M., Clallam County.
