This proposal was initiated by Rayonier Washington Timber Company to even age harvest 112.8 acres of timber. The site is located in the vicinity of the East Fork of the Dickey River and is located approximately 6 miles northwest of the City of Forks. Timber harvest will occur within mapped glacial deep seated landslides and their associated ground water recharge areas. In addition harvest will occur over but not within a mapped inner gorge. These features are described in the geotech report along with analysis and recommendations for protection of the unstable features. Other aspects of the proposal include 300' of new road construction and maintenance of 1.5 miles of existing roads.

Yes, there are 4 mapped glacial deep seated landslides within or immediately adjacent to the proposal There are also streams with inner gorge features and a bedrock hollow feature. These sites vary from dormant to active. All are described in the Geotech report.

e. Describe the purpose, type, total area, and approximate quantities and total affected area of any filling, excavation, and grading proposed. Indicate source of fill.

Seven stream crossings and 16 cross drain culverts, on existing roads will be replaced requiring 1050 cubic yards of gravel fill. The total area of filling is < 0.5 acres. In addition 300' of new road construction will require 360 cubic yards of gravel on 0.2 acres. Gravel for fill will be obtained from a local gravel pit.

f. Could erosion occur as a result of clearing, construction, or use? If so, generally describe. **Yes, minor amounts of erosion will occur associated with road use as well as timber harvest.**

h. Proposed measures to reduce or control erosion, or other impacts to the earth, if any: **Inner gorge and bedrock hollow feature were excluded from the harvest area and will not be disturbed. Harvest on DSL features and their associated recharge areas is limited to only those areas reviewed and approved by a licensed geologist. Additional buffering was provided at Point 10, Points 28-29 and Points 32-34 in recognition of minor slope movement; these are critical places to leave additional trees that may limit movement or**

eventually deliver large woody debris to the E. Fk. Dickey River and Ck 3. (Point numbers refer to specific locations outlined in the Geotech report related to this proposal).

The East Fork Dickey River, which is a Type S stream forms the western boundary of the proposed harvest. Several type F and NS streams bisect the unit before flowing into the river. Two non-typed streams, that have no connection to the river also bisect the site.

Yes. Cable tailholds may be suspended over the river and all other streams in the proposal. Full suspension yarding will occur over a type F stream. Harvest activities will occur in and over type NS streams. Culvert replacements and installations will occur on 7 type NS streams.

Summary of Comments

I have reviewed this SEPA Checklist and have the following comments:

A. Background

8. The Geotechnical Report for Rayonier's Unit 29N14W540 in the East Dickey River Watershed is available on FPARS with FPA/N 2616713.
10. FPA/N 2616713 and the associated Geotechnical Report for Rayonier's Unit 29N14W540 in the East Dickey River Watershed are available for viewing in FPARS.
11. FPA/N 2616713 indicates approximately 112.8 acres of even-aged and salvage harvest with an estimated 2,256 MBF of timber removed using shovel, FS & LES Cable, CAT logging, and helicopter harvesting methods in three harvest units. The FPA also indicates approximately 300 feet of road construction and spoils deposits totaling approximately 700 cubic yards are included. Seven Ns crossings are planned (per Question 14 of FPA/N 2616713).
12. The location of this proposal is confirmed as Sections 13, 23, 24 in Township 29 North, Range 14 West in Clallam County, per Question 7 of FPA/N 2616713.

B. Environmental Elements

Earth

- 1.b. The steepest slope is confirmed in the Geotechnical Report for Rayonier's Unit 29N14W540 in the East Dickey River Watershed.
- 1.d. The FPA/N, Slope Stability Informational Form, CMZ Assessment Form, and Geotechnical Report for Rayonier's Unit 29N14W540 in the East Dickey River Watershed indicate that inner gorges, bedrock hollows, deep seated landslides, and groundwater recharge areas are found in and around the harvest units. A CMZ Assessment Form for the East Fork Dickey River is included with the FPA/N.

Water

- 3.a.1. FPA/N 2616713 indicates multiple typed streams in the vicinity of the harvest units.
- 3.a.2. FPA/N 2616713 indicates harvest will occur within 200ft of type S and F waters (per FPA/N question 25). Activities outlined in FPA/N question 15 will also occur in or over type S, F, and Ns waters.

Plants

- 4.b. FPA/N 2616713 indicates approximately 2,256 MBF of timber will be harvested (per question 19).
- 4.c. FPRAM check indicates no potential conflicts with T&E plant species.

Animals

- 5.b. FPRAM check indicates the proposed harvest units are within are within a MM detection area and within a MM 1.5 mi occupied buffer.
- 5.c. Washington State is considered part of the Pacific Flyway; however no impacts are anticipated as a result of this proposal.
