SUBJECT: **SEPA LEAD AGENCY & DETERMINATION OF NONSIGNIFICANCE**

This is to advise you that pursuant to WAC 197-11-900 (922 through 948), the Department of Natural Resources has determined that it is Lead Agency for the following:

**Forest Practice Application #2618076 and Oh Brian Timber Sale #104795 proposal consists of 195 acres with 143 acres of even-aged harvest within 3 units, 51 acres of uneven-aged harvest within 1 unit, and 1 acre of right-of-way harvest within 1 unit, removing approximately 3,029 MBF. The proposal will be harvested using shovel, tether, cable, tracked/rubber skidder, processor, and forwarder harvesting methods. The proposal includes approximately 12,365 feet of road construction and .25 acres of rock pit expansion. Due to unstable slopes, the proposal is a Class IV-Special. Located in Section 18, Township 29 North, Range 04 West, and Sections 23, 26, Township 30 North, Range 05 West, W.M., Clallam County.**
