SUBJECT: **SEPA LEAD AGENCY & DETERMINATION OF NONSIGNIFICANCE**

This is to advise you that pursuant to WAC 197-11-900 (922 through 948), the Department of Natural Resources has determined that it is Lead Agency for the following:

Forest Practice Application #2618096 and Salt and Pepper Timber Sale #103769 proposal consists of 66 acres of even-aged and right-of-way harvest within 5 harvest units, removing approximately 2,417 MBF and 528 tons of biomass. Planned harvest methods include rubber-tired skidder, tracked skidder, dozer, shovel, full suspension cable, leading end suspension cable, helicopter, cable assist/tethered logging, and forwarder. The proposal includes approximately 5,585 feet of road construction, approximately 3,000 cubic yards of spoils, and 0.5 acres of existing pit expansion. Due to potentially unstable slopes, the proposal is a Class IV-Special. Located in Sections 10, 11, 12, 13, 14, 15, Township 30 North, Range 08 West, and Section 18, Township 30 North, Range 07 West, W.M., Clallam County.
