SUBJECT: **SEPA LEAD AGENCY & DETERMINATION OF NONSIGNIFICANCE**

This is to advise you that pursuant to WAC 197-11-900 (922 through 948), the Department of Natural Resources has determined that it is Lead Agency for the following:

Flutterby Timber Sale #99655 and Forest Practice Application #2616500 proposal is a variable retention harvest composed of six units, and three right-of-way units, with approximately 146 net acres, and an estimated sale volume of 3,281 MBF of timber. The proposal includes 6,365 feet of new road construction, 1,350 feet of reconstruction, 28,970 feet of pre-haul maintenance, and 2,715 feet of decommissioning are proposed to meet access needs into the sale area. Located in Sections 07, 08, 17, 18, Township 30 North, Range 07 West, Section 33, Township 31 North, Range 07 West, W.M., Clallam County.
