This is to advise you that pursuant to WAC 197-11-900 (922 through 948), the Department of Natural Resources has determined that it is Lead Agency for the following:

**Last Crocker Sorts Timber Sale #104812 and Forest Practice Application #2618086 proposal consists of four variable retention harvest units totaling 141 net harvest acres and two right-of-way units totaling 1 acre, with a cruised volume of 5,447 MBF. The proposal includes approximately 3,615 feet of optional construction, 425 feet of required reconstruction, and 17,095 feet of required pre-haul maintenance. The sale is to be harvested using ground-based shovel methods, with a timing restriction area in Unit 4. Located in Section 13, Township 28 North, Range 02 West, W.M., Jefferson County.**
