This is to advise you that pursuant to WAC 197-11-900 (922 through 948), the Department of Natural Resources has determined that it is Lead Agency for the following:

**Maud Bull Timber Sale #107511 and Forest Practice Application #2618591 proposal is a four unit timber sale encompassing approximately 312 gross acres, with 192 acres of variable retention harvest, and a cruised volume of 5,004 MBF. The proposal includes approximately 55,170 feet of pre-haul maintenance, 720 feet of decommissioning, and 1,260 feet of new road construction is planned to provide access to the sale area. Located in Sections 09, 16, 17, Township 25 North, Range 11 West, W.M., Jefferson County.**
