This is to advise you that pursuant to WAC 197-11-900 (922 through 948), the Department of Natural Resources has determined that it is Lead Agency for the following:

Tomauder VRH Timber Sale #100885 and Forest Practice Application #2616617 proposal is a variable retention harvest composed of one unit of approximately 90 gross acres, with a cruised volume of 1,853 MBF being harvested using ground-based and cable harvesting methods. The proposal includes 10,690 feet of pre-haul maintenance and 150 feet of new construction to provide access to sale area. Located in Section 09, Township 31 North, Range 12 West, W.M., Clallam County.
