This is to advise you that pursuant to WAC 197-11-900 (922 through 948), the Department of Natural Resources has determined that it is Lead Agency for the following:

Bull Wacker Timber Sale #83240 and Forest Practice Application #2939631 proposal is a variable retention harvest of 133 acres in 2 units, and 7 acres of right of way harvest in 1 unit, for a total of 140 acres in 3 units, removing approximately 5,851 MBF of timber. The proposal includes 5,968 feet of road construction, 3,370 feet of road reconstruction, 39,682 feet of pre-haul maintenance and 1,188 feet of road abandonment. Located in Sections 09, 16, 21, Township 11 North, Range 09 West, W.M., Pacific County.
