This is to advise you that pursuant to WAC 197-11-900 (922 through 948), the Department of Natural Resources has determined that it is Lead Agency for the following:

Liter Cola Timber Sale #107775 and Forest Practice Application #2943117 proposal is for a variable retention harvest with 59 acres in 4 units, and 3 acres of right of way harvest in 2 units, for a total of 62 acres in 6 units, removing approximately 2,317 MBF of timber. The proposal includes 140 feet of road construction, 2,980 feet of road reconstruction, and 52,649 feet of pre-haul maintenance. Located in Sections 20, 28, 29, Township 09 North, Range 03 East, and Section 23, Township 09 North, Range 02 East, W.M., Cowlitz County.
