SUBJECT: **SEPA LEAD AGENCY & DETERMINATION OF NONSIGNIFICANCE**

This is to advise you that pursuant to WAC 197-11-900 (922 through 948), the Department of Natural Resources has determined that it is Lead Agency for the following:

**Forest Practice Application #2424236 proposal is for approximately 66 acres of even-aged harvest with an estimated 1,650 MBF1 of timber being removed utilizing ground based harvesting methods. Approximately 3,000 feet of temporary road construction is included. Forest Practices rule-identified unstable landforms are located adjacent to the proposed project area, and the harvest is within an approved Watershed Analysis Unit where the proponent is deferring to standard Forest Practices Rules. Located in Section 33, Township 21 North, Range 11 East, W.M., King County.**
