Description: This amendment to the existing PMA agreement will allow the use of State-owned aquatic lands for the sole purpose of operations authorized by a Washington Public Port District. It is located on Grays Harbor, in Grays Harbor County, Washington.

The Port has requested eligible State aquatic lands be added to the existing Port Management Agreement. The properties (2 parcels) abut existing PMA parcels at the Port Terminal 3 (former Rayonier site) and the Ports Terminals 1,2,4, formerly the WDOT pontoon construction site.

This is a non-project action, expanding agreement boundaries consistent with 79.105.420 RCW. The Terminal 3 site is currently proposed for development of a Pot Ash terminal. Any future development proposals for the sites will be subject to the local, State and Federal regulatory process.

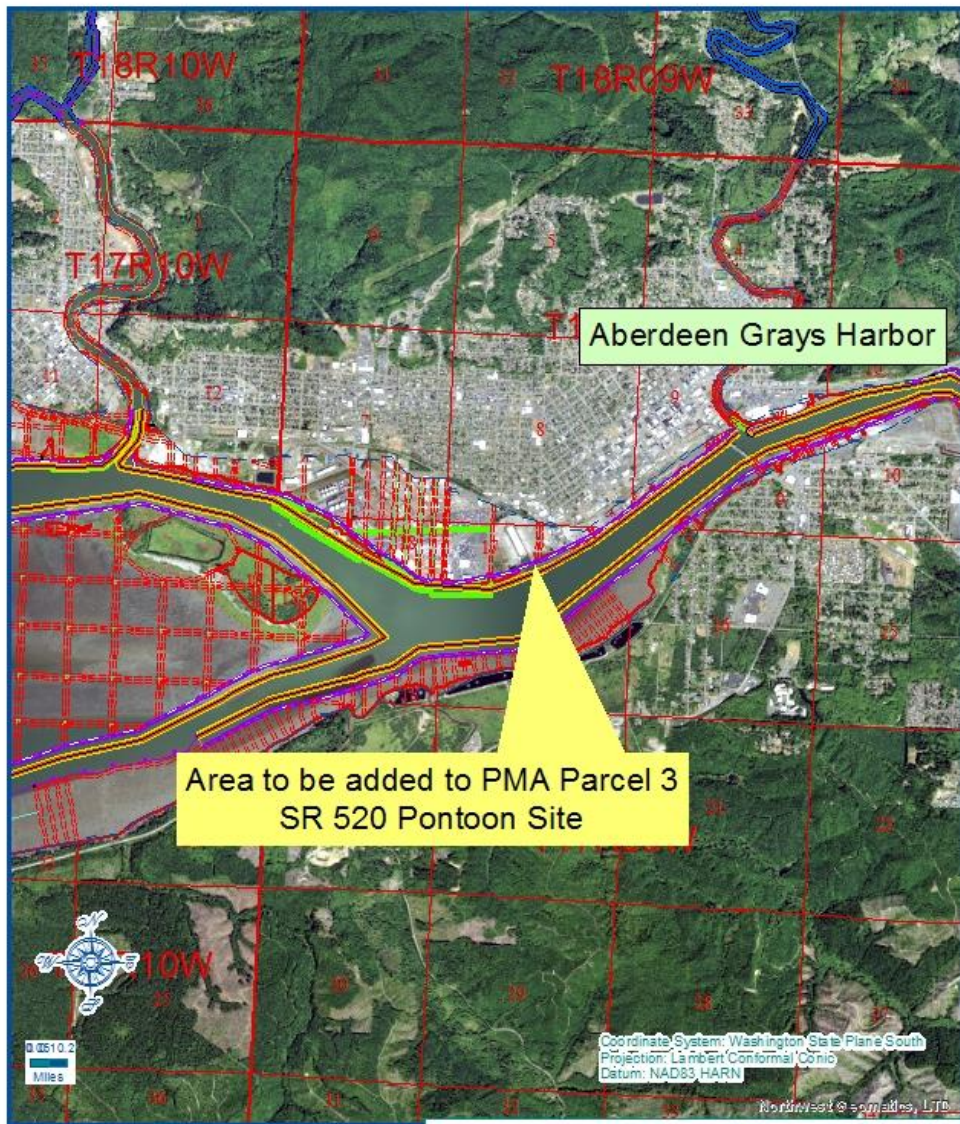
