29	SEPTEMBER 9, 2003 - FIELD TOUR
30	The Board, staff, and public met at the Yakima Red Lion Hotel in Yakima to begin the field tour.
31	The tour included private and state owned sites. Discussion topics were culvert installation to
32	improve fish passage, Road Maintenance and Abandonment Planning (RMAP), Perennial Initiation
33	Points (PIP), and eastside forest health issues. The field tour ended at 4:30 p.m.
34	
35	SEPTEMBER 10, 2003 – SPECIAL MEETING
36	CALL TO ORDER
37	Pat McElroy called the meeting to order at 9:05 a.m. Karrie Brandt gave an emergency safety
38	briefing. Introductions were made of the Board, staff, and attendees.
39	
40	PUBLIC COMMENT
41	Alan Pleus, Northwest Indian Fisheries Commission, commented on the PIP site visit on the
42	previous day's field tour. Pleus stated that from the tribe's point of view there is a wide range of

- 1 situations on the eastside, including some anomalies. To assist in dealing with these dry situations
- 2 and type 4 functions, Cooperative Monitoring, Evaluation and Research (CMER) has initiated
- 3 the type N (non-fish waters) study. The scientific analysis will identify the functions and the best
- 4 way to differentiate between a type NP (non-fish perennial waters) and a NS (non-fish seasonal
- 5 waters).

FIELD TOUR DISCUSSION

- 8 Wendy Holden complimented staff for their efforts in putting together the retreat. She felt the site
- 9 examples suitably illustrated the problems that people were having with the rules. She hoped that
- 10 the Board would consider the impacts that the details of the rules have especially the way people in
- 11 the field pour over them and take the rules literally. Holden thought the Board needed to be careful
- about its choice of rules and words to make sure that sufficient flexibility for appropriate levels of
- professional judgment in the field is built into them so not to be so prescriptive that unintended
- 14 consequences are created.

15

- Mankowski shared cost estimates on culvert installation for fish passage. The estimates were jointly
- 17 created by the Department of Fish and Wildlife (DFW) and the Department of Natural Resources
- and provided by six small forest landowners in western Washington. Some factors that affect cost
- include road width, engineer and operator experience, depth of road fill, and road alignment at
- stream crossing. Costs range from \$4,000 for 5-8 foot culverts to \$50,000 for a 50 foot steel bridge.
- 21 The Board would like to be apprised as new data and costs estimates are developed.

- 23 Mankowski agreed with Holden that latitude should be built into the rules. Along with a good
- training program that provides an understanding of what the function and values are of the rules.

- Hagiwara also thanked staff and commented on the importance of the Board receiving feedback
- 27 from field folks on how the rules are working. He values the discussions in the field and would
- advocate for more field tours.

29

- 30 Soicher stated that the intent of a rule should be stated in the Board Manual sections and in the
- 31 rules. He supports some flexibility in the rules to allow for professional judgment but they also need
- 32 to be prescriptive to an extent.

BOARD MANUAL DEVELOPMENT PRIORITIES

- 2 Marc Engel presented a timeline created by stakeholders and Board staff for action on revising and
- 3 developing Board Manual sections over the next two years, which included targeted approval dates
- 4 and a priority order. Sections that will be before the Board in the near future include Shade
- 5 Requirements, Channel Migration Zone (CMZ) and Bankfull Width, Forest Roads, Watershed
- 6 Analysis, Determining Fish Use, and Alternate Plans.

- 8 Alan Soicher asked if the sections on Determining Fish Use and Guidelines for Field Protocol
- 9 would be ready when the watertyping model is complete. Engle responded yes, that is the
- 10 intent.

11

- 12 Soicher also suggested that the Adaptive Management section be developed sooner than 2005. The
- 13 Board concurred and asked Engel to make Section 22 a higher priority.

WILDLIFE PLANNING

- 16 John Mankowski stated that he would like to have project scoping information for the Board at the
- 17 November meeting. Then he would like to schedule a workshop for December to present the
- 18 complex issues to the Board. A special meeting for the Board will be held on December 2, 2003, for
- wildlife planning.

DEVELOP BOARD'S 2004 WORKPLAN

- Ashley DeMoss reviewed the work plan that was established last year and provided a progress
- report on those activities. The Board's 2004 work plan includes ongoing activities from 2003 such
- as rule making on RMAPs, marbled murrelets, cultural resources, the Board's procedures and ethics,
- and administrative rule clarifications. Other anticipated Board activities include a pilot for testing
- riparian rules, revising and developing Board Manual sections, the new water type model and maps,
- ongoing work with DFW on its wildlife assessment and rule review, rule recommendations from
- adaptive management research, and response to Critical Wildlife Habitat Designations by the
- services for listed salmonids. In addition, panel discussions on the economics of a "viable forest
- 30 products industry" and field practitioners reporting on Forests and Fish rule implementation were
- 31 also expected.
