31 Field Tour

- 32 The Board, staff, and public met at the Natural Resources Building in Olympia. The tour took place
- 33 on Port Blakely Tree Farm and included three sites. Stop #1 focused on the desired future condition
- 34 rule making. Discussion included current rule, the three proposed rules and a fixed width concept.

- 36 Stops 2 and 3 focused on Port Blakely's 35 and 65 year old plantation and the consideration of a
- 37 Safe Harbor Agreement with the federal services and a Landowner Option Plan with the state of
- 38 Washington for management of forest lands within a rule established Spotted Owl Special Emphasis
- 39 Area.

25 WELCOME AND INTRODUCTIONS

- 26 Vicki Christiansen called the Forest Practices Board (FPB or Board) meeting to order at 8:30 a.m.
- and introductions of Board, staff and public followed. Marc Engel, Department of Natural
- 28 Resources (DNR or Department), provided an emergency safety briefing.
- 29

30 FIELD TRIP RECAP

- 31 Chuck Turley, DNR, stated that it was clear that a variety of analyses from different caucuses is
- 32 being done in different ways on desired future condition (DFC). He said he believed that this
- 33 accounted for a lot of the difference that the Board was hearing regarding whether things were truly
- 34 impacted or not.
- 35
- 36 Doug Stinson stated that if he had to make a decision today that he would oppose any new rule. He 37 said the 325 proposal is overkill and it would be a rare forest that reaches that basal area. He said 38 that it is too complicated and costly for the landowner and DNR to administer. He suggested that
- the Board have a panel presentation from a cross section of scientists to hear their perspectives. He
- 40 said the small forest landowners need assurances that the trees they plant today can be harvested in
- 40 said the small forest failed where need to be reasonable for landowners to make a fair return on their
- 42 investments. Without these two incentives small forest landowners will go away.
- 43
- 44 Moran stated that she was struggling with the need for simplicity and flexibility for small forest
- 45 landowners. She heard on the field tour that because of the complexity of the rule, small forest
- 46 landowners do not choose the DFC route unless they hire consultants. She stated that the Board is
- 47 looking at a simplistic no cut buffer but if that is not the right direction, the Board needs to know.
- 48

- 1 Sherry Fox said small forest landowners currently have an overstocked stand template available that
- 2 allows for thinning down to 100 trees per acre.
- 3
- 4 Dave Somers said he would like to support ways to simplify the process and the field tour helped
- 5 him to believe this can be accomplished. He states, however that it seems likely that some analysis
- 6 may need to be done in order to accomplish the management of future conditions and riparian7 zones.

- 9 Christiansen said she has made the fixed width concept a priority for staff to report back to the
- 10 Board on whether this is a viable alternative.
- 11

Norm Schaaf said he hoped a simpler process was possible that protects function. He said he was encouraged at Stops 2 and 3 to see the cooperation between the agencies and the landowner in developing a plan that would work for all the parties involved. He would like to see this continue because it would achieve multiple goals and multiple agreements.

- 17 Fox asked for an update on whether the growth model has been fixed. Graves responded that the
- 18 numbers have been updated and it repeatedly was running correctly, and it appeared that when the
- 19 Board adopts a rule, it will take only minor programming to get it working by the time the rule
- 20 becomes effective.
- 21
- Moran asked staff if they were using a new version of ORGANON. Turley replied that staff looked
 into Version 8.0 and it was decided for a true comparison to be made DNR would need to update
 and fix Version 6.0, which is the current version being used.

- 26 Board Members agreed the Board would like to have a briefing on the two versions of ORGANON
- to better understand the differences and the pros and cons of each version. Staff noted this requestwill be evaluated as the rule makings move forward to see which direction the Board takes.

30 Carolyn Dobbs encouraged the cooperation and collaboration that occurred with Port Blakely in

31 establishing alternative management strategies to continue and to include this approach in the

- upland wildlife planning. She said she would like to see this made available to other landowners aswell.

35 CLIMATE CHANGE EFFORTS

36 Craig Partridge, DNR and Stephen Bernath, Department of Ecology (DOE), provided a presentation 37 on "Greenhouse Gas Mitigation", specifically the recommendations from the forest sector work 38 group. The work group's priorities for 2008 are conversion, forest management and harvested wood 39 products, and reforestation. Future goals include substitution of biofuels, avoided emissions from 40 fire and forest health and substitution of wood for fossil fuel-intensive products. The work group 41 will provide recommendations by November 1, 2008 to Commissioner of Public Lands and Director 42 of DOE, and by December 1, 2008 final recommendations to the Directors of DOE and 43 Community, Trade and Economic Development. The Engrossed Second Substitute House Bill 2815 44 report will be provided to the legislature. The work will continue with future priorities and 45 developing detailed protocols and funding decisions.

1 FOREST CERTIFICATION

- 2 Clay Sprague, DNR, provided a presentation on the four forest certification systems. The four
- 3 systems are American Tree Farm System, Forest Stewardship Council, and Sustainable Forestry
- 4 Initiative and Programme for the Endorsement of Forest Certification Schemes. The presentation
- 5 included the history and origin, general features, and standards and principles of each system. All
- 6 the systems had the following common elements: A set of standards, a third party verification,
- 7 practices to assure consumers of sustainable forest management, chain of custody, and voluntary
- 8 and non-regulatory approach.
- 9

10 **OVERSIGHT OF COMPLIANCE MONITORING**

- 11 Gary Graves, DNR, provided an update on the Division's progress on establishing an advisory
- 12 committee to oversee the compliance monitoring program. He said he did not have a
- 13 recommendation yet, and that Lenny Young, Bridget Moran and Tom Laurie would meet to finalize
- 14 a recommendation. He said he would provide a report at the November 2008 meeting.
- 15
- 16 Moran said she believed staff is on the right track. She looked forward to the report in November.
- 17

18 MASS WASTING PROJECT UPDATE

- 19 Darin Cramer, DNR, provided a written update on the Mass Wasting Prescription Scale
- 20 Effectiveness Monitoring project. The report included a list of completed tasks, ongoing tasks and a
- 21 budget summary. He stated that staff will report to the Legislature in December on the project.
- 22

23 **OVERVIEW OF DNR BUDGET REQUESTS**

- 24 Chuck Turley, DNR, provided an overview of the Forest Practices program budget requests that
- 25 have been submitted to the Office of Financial Management for consideration. There are a total of
- 26 six packages, four operating packages and two capital projects. The operating packages are
- 27 Unstable Land Forms, Landowner Incentives, Expert Forestry Assistance, and Landscape-Level
- Wildlife Assessment for an approximate total of \$4 million. The two capital projects are Family 28
- 29 Forest Fish Passage Program and Forest Riparian Easement Program for an approximate total of \$41 million.
