

## **CULTUS - BLANCHARD ACQUISITION**

### **PROPOSAL**

The Department of Natural Resources proposes to purchase 826.30 acres, more or less, of real property located in Skagit County and owned by Weyerhaeuser Columbia Timberlands, LLC, a Delaware limited liability corporation, successor by merger to Longview Timberlands, LLC. The purpose of this purchase is to replace State Forest Land Trust timber previously deferred from harvest and acquire land that is productive, working forest land. The purchase is authorized by RCW 79.17.210 and by the appropriation and provision of Section 3032, Chapter 35, Laws of 2016 1<sup>rst</sup>Special Session.

#### **BENEFITS**

The State Forest Land Trust will acquire property that has income production potential. The purchase will also block up trust lands and remove private land inholdings.

#### **GENERAL LOCATION**

The property is approximately eight miles southeast of Sedro-Woolley and eight miles east of Mount Vernon and is within Sections 27, 34 and 35, Township 34 North, Range 5 East, W.M., in Northwest Region.

#### VALUATION

Purchase price is \$1,850,000.


### **COMMENTS**



A **RESOLUTION** relating to the purchase of real property by the Department of Natural Resources of the State of Washington from Weyerhaeuser Columbia Timberlands, LLC, a Delaware limited liability corporation, successor by merger to Longview Timberlands, LLC (hereinafter referred to as "Seller", as authorized by the appropriation and provision of Section 3032, Chapter 35, Laws of 2016 1<sup>rst</sup> Special Session, under Department of Natural Resources Purchase File No. 08-094576.

# BE IT RESOLVED BY THE BOARD OF NATURAL RESOURCES, DEPARTMENT OF NATURAL RESOURCES, STATE OF WASHINGTON, THAT:

**SECTION 1.** Seller is the owner of the real property described in Exhibit A, attached hereto which by this reference is made a part hereof.

SECTION 2. The Board of Natural Resources finds that purchase of the real property described in Exhibit A as replacement trust property is authorized by the appropriation and provision of Section 3032, Chapter 35, Laws of 2016 1<sup>rst</sup> Special Session. The purchase of real property described herein contributes to the real property asset base, has income potential, and is therefore suitable for replacing State Forest Land Trust timber at Blanchard State Forest previously deferred from harvest in the "core area" described in the Memorandum of Understanding for the Blanchard Forest Strategies Group signed in 2008.

**SECTION 3.** The Commissioner of Public Lands is authorized to execute such agreements, writings, and relinquishments and to certify and approve such deeds as are necessary or proper to complete the purchase of the above referenced real property.

#### SUBJECT TO THE FOLLOWING CONDITIONS:

- A. Seller will convey the property to the State of Washington by bargain and sale deed and will furnish, at their expense, a policy of owner's standard title insurance in the full amount of the purchase price.
- B. The Department of Natural Resources is authorized to disburse \$1,850,000 from the legislative appropriation in Section 3032, Chapter 35, Laws of 2016 1<sup>rst</sup> Special Session for acquisition of the replacement trust property described in Exhibit A and for payment of compensating taxes as required by the Purchase and Sale Agreement.
