

# Teanaway Community Forest



**Public Comment Received from 6/14/2014 – 7/11/2014**

*Note: The 238 comments were separated into goals in order to facilitate reading.*

➤ **Goal 1: Protect and enhance the water supply and protect the watershed; (3 comments)**

07/02/2014	I strongly support active restoration of riparian and older forest habitat conditions in Teanaway Community Forest. Unauthorized trails must be rehabilitated, logging roads with aquatic impacts or threats to critical elk habitat should be removed, and there must be an end to illegal riding. This is a COMMUNITY forest. Not a free-for-all for a specific interest group who make it unusable to everyone else.
06/23/2014	Please protect the watershed from unauthorized use.
06/21/2014	I am interested greatly in how restoration in these new public lands can increase natural water storage from forest management to old logging road abandonment to reintroducing beavers. This being such a primary reason for this purchase, it is important to me that we do not get caught up in recreation planning or other issues until a clear picture of what the potential is to increase water quality and quantity with these new lands for the Yakima basin.

➤ **Goal 2: Maintain working lands for forestry and domestic livestock grazing while protecting key watershed functions and aquatic habitat; (4 comments)**

07/08/2014	Under the assumption that the Teanaway Community Forest is to actually be a multiple use forest and not a "forest for the privileged few" a well designed system of single track trails for motorized trailbike riding should be developed as soon as possible. In 2005 the USFS published a study "Off-Highway vehicle recreation in the United States, regions and States: A National Report from the National Survey on Recreation and the Environment". That study found OHV use to be one of the fastest growing outdoor activities. Unfortunately in the State of Washington motorized trail bike riders have great difficulty finding legal and suitable places to camp and and enjoy family trail riding outings. Well designed trail bike trails are a critical issue for enthusiasts in this State. It is the hope of the motorized trail community that the Teanaway Forest project will help to resolve the need for single track motorized trail recreation. It is also the hope of this community that it will not be subjected to the anti-motorized trail bigotry and malicious discrimination that has happened at times in the past.

07/07/2014	I am writing today to request that off-road motorcycle use continue to be allowed in the Teanaway Community Forest (TCF). Off-road motorcycle riding at the TCF is an activity that brings people together from across WA state, OR and ID to share a common passion and learn lessons about perseverance overcoming challenges and teamwork. I personally hold many wonderful memories with my father and our family friends riding off-road motorcycles as a child in the 1990s and early 2000s. Now that I've graduated college and found career success with a large employer, I've looked back at the time I spent at the TCF and am reminded about how important those years were to my development as a productive citizen. Off-road motorcycle riding is a use of this land that the local

	<p>community has always supported, both as a healthy family activity and as a driver of significant tourism revenue. Now that I am financially established, I bought a new motorcycle this year to ride this area and to begin creating new memories both with my friends, and with my nieces and nephews, eventually my own children, and my father, whom has stayed healthy and fit into his 60s because his love of off-road motorcycling. My most frequent group of riding partners consists of 8-10 young professionals, making the trip to Cle Elum from places including Bellingham, Seattle, Sandpoint, and Hood River. Each time we're in town we patronize local restaurants like Beau's Pizza and Pasta and Gunnar's Coffee Cabin, we purchase upgraded gear and replacement bike parts in town, and we book rooms at local hotels. We make this trip many times during the year to ride at the TCF, and as I mentioned in the previous paragraph, now that many of us are starting families, we hope to continue to make this trip for many years to come. Most importantly, the primary purpose for creating the Teanaway Community Forest is to preserve it as a working forest. The DNR has a legal requirement to allow multiple uses of the land when it does not compromise their trust management obligations. Due to the previous four decades of ORV use, the area has a robust and sustainable multi-use trail system. This trail system has been continuously improved over this time to mitigate environmental impact and increase user safety. There are many examples in nearby areas that prove the popularity and effectiveness of managing a multi-user outdoor recreation area for the benefit of tourism and attracting lucrative employers, including the impressive popularity of the Post-Canyon area in Hood River, Oregon. ORV use has historically proven to be one of the best integrated and most popular uses within working forests, and as such should be prioritized accordingly. 07/03/2014	I have been camping and dirt biking in this area all of my life. I hope I can continue to bring my family and friends to this great area.
07/03/2014	Please include single track offroad motorcycle recreation in the planning process. This use has been taking place in this area for decades, if not a half century.
07/03/2014	I have ridden my motorcycle in the Teanaway forest for many years and wish it to remain open for me to enjoy on my motorcycle.
07/03/2014	Please allow motorized OHV use as part of the plan. This is compatible with a working forest and has long been part of the local community.
07/03/2014	I'm a lifelong Washington resident and now bumping into 45. On my 5th birthday I received a little Honda MR50. That was the start of many family camping trips, some of which took us to the Cle Elum area. That was the '70's when offroad motorcycling, or "dirt biking", was a younger sport. Today, ORV use is much more prevalent. It continues to be a family sport. We are mostly confined to the same riding areas that we have been using for over 40 years. Many of these are DNR "working forests": Walker Valley, Capitol, Tahuya and Jones Creek for example. With the sport's popularity increase one would think that public riding areas would have increased commensurately over the years. This hasn't been the case and now the need for access to public riding areas is higher than ever before. The Teanaway Community Forest is to be a working forest and as such the DNR must allow multiple recreational uses. Dirt biking should be one of them. Some of the existing trails within the now-established boundaries of the TCF have provided ORV recreation for decades. Whether or not that usage was approved or legal in the past is moot; the TCF is now a working forest and by law, the DNR must allow multiple uses. If a use case doesn't compromise the DNR's trust management obligations then it should be allowed if user demand is great enough. The land within the TCF boundaries has a long history of dirt biking on single-track trails and so establishes the user demand. For comparison, the aforementioned DNR working forests have supported ORV use for decades. In fact I have many fond and exciting family camping trip memories of riding in them (we were at Capitol the day Mt St Helens erupted in 1980!). ORV usage is a very compatible use case in working forests; this has been long established when considering the other DNR working forests noted earlier. The landscape within the TCF is scenic and unique. As such, it is a "destination recreation area" as dirtbikers have traveled from outside areas to ride the trails. This injects outside dollars into the local economy. ORV use on the land has always had support from a large portion of the local community. The TCF Committee should include a sub-team of offroad motorcyclists comprised of individuals who have experience with: 1) Practical and applied ORV trail maintenance and construction. 2) Environmental topics. 3) The existing trail system. Finally, I urge the DNR to take a position of trusting the proactive offroad motorcycling community. We understand the issues of motorized recreation in the outdoors and have developed solutions to mitigate the issues. If we didn't do anything we wouldn't have places to go. We are quite adept at supporting our riding areas.

07/01/2014	I was up hiking in the Teanaway Community Forest last week. (Bible Rock area). There were several campfires left burning (Sunday), even though the campers had left (Teanaway campground). In addition, even though the trails are clearly marked 'no motorized vehicles', there were motorcycles going wherever they pleased. The hikers, equestrians & mountain bike folks all seem to respect the rules--why can't the ORV people? After seeing the Daily Record article about how they are pushing hard for more ORV access, I can't help but worry that this area will turn into a new version of Naches Creek off of Highway 410. Up in that area, where motorcycles, ATVs and Jeeps all have trail access, it is unsafe for hikers, mountain bikers & equestrians. Too many vehicles going too fast, on too many blind curves. In addition, the campgrounds are trashed, as the type of people who do ORV seem to be less concerned about the environment than others.
06/30/2014	I believe there should be a limit to how many motorized recreation parks there are. If we want to keep a natural environment allow the equine riders and hikers have their trails, as off road (motorized vehicles) already have a huge impact on trails, and already have trails established and in use already.
06/30/2014	I hope that the Teanaway Community Forest, as befitting its name, offers a variety of opportunities for diverse user groups and does not cater to any single group. I hope the state commits to a serious LEO presence in the area or this will become a total shit show.

06/29/2014	After reading almost 100 opinion submittals for the expansion of ATV/ORV use in the newly created Teanaway Community forest I find it interesting that there is not one submittal in opposition. I also note that in all proponents letters the only reason they could give for expansion of off road riding was because they wanted more room to ride. Clockum, L.T. Murray, Yellow hill, Liberty, Taneum, Manastash, Fortune Creek, provide a lot of off road trails for both ATV and ORV use. The Teanaway Water Basin Enhancement Forest was created to enhance and preserve an area for watershed preservation. I fail to see how expanded ATV/ORV use meets any of the supporting criteria for that goal.
06/29/2014	If allowing ATV/motorized vehicle use in the forest, please consider restricting it to roads due to the damage caused by tires on trails (especially wet trails). I know we all must share the area, but I go to the forest for the peacefulness, quiet, and wildlife, not for the noise of vehicles.
06/29/2014	Would like to see trails for hikers (both Day and Backpack), which means designated camping areas with outhouses too. If practical a separate trail for mountain bikes would also be nice; but a distant second to hiking trails.
06/28/2014	The blatant and intentional exclusion of ORV's from the interim travel plan is unacceptable. I've been riding dirtbikes and quads back there for years and so have many of my friends and neighbors. Since rumors of this purchase began to surface I've been pressuring the DNR non stop (along with many others in the offroad community) to make sure we are not marginalized. Turns out public comments and opinions only matter from some groups as we were totally ignored. Get your act together DNR. Motorized recreation is vital to this area. Fix this problem immediately, not next summer.
06/28/2014	Please provide additional space for more rigs to horse camp. Spot's for highline's for overnight camping with horses. If motorcycles are going to be allowed please mark trails that would be for equine and hikers verses motorcycles all on the same trail system. Thank you so much for allowing public input. We love Indian Camp and come up regularly. Ann Mokry
06/28/2014	My concern is that the trails remain open and safe to us equestrians!
06/27/2014	I have been riding up in the area for decades and love that I don't have to compete with motorcycles. Please keep it that way.
06/27/2014	We would like to see separate bike/hike/horse trails.
06/27/2014	Purpose built bike trails please. No motos, they destroy the trails.
06/27/2014	Non motorized trails are what I want, especially for mountain bicycles
06/27/2014	Yay mountain biking! I am new to mountain biking but we are heading to Teanaway this weekend to try out the trails. The more mountain biking trails, the better! It's such a great, low-impact way to enjoy open and wild places - please do what you can to preserve and protect it for this use (as well as other low-impact uses, like hiking). And limit use from motorized vehicles for users' safety and important environmental impacts. 06/27/2014	Please keep it safe for horseback riding! Remind other interests that most trails were began/built by horse and mule folks. Thank you.
06/26/2014	The Teanaway Community forest helps protect wildlife, water, fish and the land it needs. Unregulated off road vehicles that chew up areas leading to erosion and areas that are hard to regenerate is counter productive. Please consider at the least regulating this recreational activity and ideally letting this beautiful area be motor free.

06/26/2014	I'm very excited to see access to the Teanaway preserved, especially for all forms of non-motorized recreation. I've hiked, biked, and cross country skied in this area for years.
06/26/2014	The ATV and motorbike trails seem the biggest problem to me.

It's one of the few areas in the county with singletrack that isn't all straight up/straight down yet you can get some decent mileage out there, so it's a great destination for people of all ability levels. Last year I did a 3 day/2 night solo bikepacking trip through the west fork drainage starting in Roslyn. It was an excellent adventure I hope to repeat some iteration of in the future. OK, so there's been a lot of discussion about moto usage out there, and I must confess I'm ambivalent about it. The moto guys who have been out there up until recently have been mainly locals, people putting around with kids, my personal heroes clearing trails with chainsaws, etc. It was kind of low-visibility and overall light use and things were all good. But if this is designated an 'official' moto destination, I can see how it could really ramp up usage and I'm not so keen on how that might work out. The soils in there are mostly sandy that gets quickly blown out and wouldn't stand up to a lot of abuse, and the LAST thing I'd want to see is it evolve into a free-for-all redneck moto mayhem scene (see every single FS sign shot out and garbage dumped all over in the Manastash area as a cautionary example). 06/23/2014	I think the first 2 miles of the West fork road should be addressed. It is real bad. It would be hard to get emergency vehicles back there if need be. Thanks
06/22/2014	I'm 56 years old, and I mountain bike for fun, exercise and because I enjoy the mountain biking community. I did the Esmerelda.DeRoux loop last year and enjoyed the ride immensely. This year, in addition to that ride, I plan to further explore the trails in the area. I have taken a couple trips to Bend, Or for riding, but if a larger selection of trails was available, I could easily see myself staying local and riding the Teanaway area for multi day vacations where I would stay in a local hotel and patronize local businesses. I am mainly a cross country/trail rider. I enjoy, and seek out, trails that include technical features such as rocks, roots, steep sections, etc, and I consider myself to have solid intermediate level skills, so intermediate to advanced level trails is what I seek to ride. I prefer the trails to have elements that challenge my riding skills. I am not interested in jumps, other than to watch other people ride them. I have no interest in ruining what would otherwise be a great day's ride by making it competitive, which means I am not interested in racing of any sort (for myself - I don't care if others want to race). I do not support shared use with motorized vehicles as they tear up the trails far too much. I have no objection to motorized vehicles in general - just mixing motorized and non-motorized vehicles. Similarly, I have no objection in general to horseman and hikers. My opinion is that there are hundreds of hiking only trails (if not thousands). It should not be a huge hurdle to establish a couple mountain biking only trails to go along with many other mixed use trails (mixed use by non-motorized users). The mountain biking community is a fast growing segment of outdoor enthusiasts, and mountain bikers are passionate about their outdoor activity. They will travel to a destination riding area and inject cash flow into the local

	economy. As far as horseman are concerned, I would say this. In the Puget Sound region, I have never seen or heard of anyone else seeing a single horseman assisting with trail building or maintenance. What I do see is numerous piles of horse waste left in the middle of the trails for other users to deal with, and numerous hoof holes in the trail. From what I have read, it would appear that due to the cost of maintaining horses, and due to other factors, the number of horsemen is declining. I think horses should be provided for to a certain extent, but if the reality is that horse ownership is in decline, that fact should factor into the plan. Thank you for considering these issues.
06/22/2014	Would love to see development of non-motorized beginner and intermediate single track trail network.
06/22/2014	I would like to see areas of the Teanaway Community Forest preserved for non-motorized recreation. I am specifically interested in trails for mountain biking and hiking. I would be in favor of not only protecting current trails but also in developing additional trails for mountain biking.
06/22/2014	The Teanaway hosts so many great trails and many of them under utilized and neglected. I'm a cyclist and ride the trails out there all summer long. I enjoy seeing all manner of users on the trail, and I would encourage the Advisory Committee to really work hard at developing and maintaining trail networks that include cycling. I support multi-use trails the longer and more contiguous or intersecting the better.
06/22/2014	I hope the committee will consider all potential users of this area; both motorized and non-motorized. Unapproved or 'rogue' motorized trail riding is currently one of the prominent uses of this area. While I'm not condoning this use, it's an indication of the demand for more legal terrain. I would encourage the committee to allow for the development of motorized trails. Mountain biking and equestrian-based recreation are also common uses for the low-elevation Teanaway forest. I think there is sufficient demand to support the development of formal non-motorized 'single-track' type trails.
06/21/2014	Please consider designating a portion of trails to mountain bike only or at least hiker mountain bike only. Horses and motorcycles cause serious damage to mountain bike trails making for less enjoyable if not impossible riding conditions. Well designed mountain bike trails are erosion free and sustainable when regularly maintained
06/21/2014	Dear Committee Members, Thank you for your efforts on behalf of the local communities and the Teanaway Community Forest. I appreciate the opportunity to provide comments about the future recreational opportunities in support of the Forest goals. I live in Cle Elum and I have been exploring the area now contained within the Community Forest for the past five years. It is a place of beauty and serenity. I use the trails in the area to hike and mountain bike. I ride and hike the trails entering into the Forest both from the Teanaway and over the Ridge from Cle Elum. I support limited multi-use of the trail system. I believe that horse back riders, hikers and mountain bikers can share the trail in harmony without destruction to the trails and the serenity of the area. I also believe that all three of these groups can help enhance tourism and recreation to the area through an improved, maintained, and mapped trail system and campgrounds. The riding and hiking in this area is superb with many unique features to draw visitors, such as rock hoodoos. Wildlife, views, and the rivers. However, this area is also delicate and sensitive to erosion and fires. Later in the summer, the trails become very dry and the Forest becomes highly at risk to fires. I want to see the area protected from motorized use. I want the prohibition of motorized vehicle use to continue for vehicles, motorcycles, and ATVs. I support this restriction due to their noise - it disturbs both people and animals and their speed on the

	<p>trails makes it dangerous for other trail users, especially horse riders. They also increase the risk of fires and force animals out of the area. The potential to draw more riders (horse and bike) to the area is large and would be beneficial to the local economy. If you look at small towns such as Fruita, CO, Bend, OR, Crested Butte, CO, and Moab, UT you can witness the economic benefits to having a maintained and mapped trail system for riders. This area has the potential for a defined and limited integrated network of trails that could support wildlife and trail users. I am also in support of the introduction and protection of wolves and the Range Rider program in this area. I have encountered a wolf in the area and I would like to see them allowed to continue their presence. There was logging within the Community Forest area in 2013 on some grandfathered private parcels. They used the access roads to bring in heavy equipment to log. It made the trails in some areas inaccessible due to the extensive levels (up to 8") of powdery dirt and subsequent erosion once the rains returned. I would like to see limitation of logging on these parcels, if possible, or the implementation of mitigation of their impact, such as keeping the dust and fire danger down by watering. This area is worth protecting. I am glad to see the State take steps to protect it. Thank you for your efforts and consideration.</p>
06/21/2014	<p>It is really great to have outdoor trails open to Hiking biking and horseback riding that are free of motorized traffic. Once the dirt bikes take over they essentially dominate the traffic on the trails. I have no problems with dirt bike riders but there machines are noisy and tare up the trail creating sand pits that are difficult to walk through and impossible to ride a bike. There is enough trail in the Kittitas valley open to motorized traffic that keeping the Teanaway Community forest free of that type of traffic will keep it unique, and attract a different crowd then other places in the valley.</p>

This forest would provide access for a large group of Eastern/Central Wa recreationalists and also provide access to the Cascades and high mountain opportunities. Thanks for your consideration.</p>
06/21/2014	<p>As a resident of Ellensburg, I fully support mountain bike access to the Teanaway area. While I understand the draw of the area to equestrian and motorcycle enthusiasts, I cannot support their unsustainable use of the area.</p>

06/19/2014	Please allow mountain bike usage and trail maintenance and development. Bikes are much less impact than horses and ATV's and we as citizens all have a right to travel the forests...thanks!
06/19/2014	Bicycles should not be allowed in any natural area. They are inanimate objects and have no rights. There is also no right to mountain bike. That was settled in federal court in 1996: <a href="http://mjvande.nfshost.com/mtb10.htm">http://mjvande.nfshost.com/mtb10.htm</a> . It's dishonest of mountain bikers to say that they don't have access to trails closed to bikes. They have EXACTLY the same access as everyone else -- ON FOOT! Why isn't that good enough for mountain bikers? They are all capable of walking.... A favorite myth of mountain bikers is that mountain biking is no more harmful to wildlife, people, and the environment than hiking, and that science supports that view. Of course, it's not true. To settle the matter once and for all, I read all of the research they cited, and wrote a review of the research on mountain biking impacts (see <a href="http://mjvande.nfshost.com/scb7.htm">http://mjvande.nfshost.com/scb7.htm</a> ). I found that of the seven studies they cited, (1) all were written by mountain bikers, and (2) in every case, the authors misinterpreted their own data, in order to come to the conclusion that they favored. They also studiously avoided mentioning another scientific study (Wisdom et al) which did not favor mountain biking, and came to the opposite conclusions. Those were all experimental studies. Two other studies (by White et al and by Jeff Marion) used a survey design, which is inherently incapable of answering that question (comparing hiking with mountain biking). I only mention them because mountain bikers often cite them, but scientifically, they are worthless. Mountain biking accelerates erosion, creates V-shaped ruts, kills small animals and plants on and next to the trail, drives wildlife and other trail users out of the area, and, worst of all, teaches kids that the rough treatment of nature is okay (it's NOT!). 06/19/2014	I have hunted and camped in this forest for the last 30 years. Some of my children learned to hunt here as well as one of my grand children. Now as I am aging I wont be able to hunt unless the state opens more access for the handicapped. I have had a disabled hunter card and placard for the last 14 years. I have applied for access to closed roads many times and have never been drawn. Hunting this area has been a life saver for me. Many of the roads are an easy hike in and out so I have been able to continue hunting. I missed last season because of a back surgery and probably wont be able to hunt again unless I get drawn for a special access area. I have never hunted any of the areas available. That brings me to the reason for this message. I believe the forest in Teanaway is ideal for this access program. If the roads are open to disabled hunters only or for the drawing system. They look to me like they would be an easy area to control access. I would even be willing to volunteer to control the gates for part of the season.
06/18/2014	Indian Camp Campground does not have enough parking for stock users. turn the flat area between the Teanaway Butte road and the existing camp into more parking camping with stock. close to the stock water trail access. a minimal of grading to smooth entrance and exit. picnic tables and firerings. High line poles.
06/18/2014	Indian Camp Campground on Middle Fork Teanaway does not have enough capacity for stock users. solution: allow stock camping in a portion of Teanaway campground / West Fork Teanaway. this is a large campground with paved access, and close to points of interest such as Bible Rock Cavern, Carlson Canyon, meadow along West Fork Teanaway known as Cadillac Flats, beautifull riding above Middle Fork Teanaway to the Aspen Grove / access to Indian Camp. river crossing to Indian Caves, about 5 miles 1 way distance.
06/18/2014	Keep this a non motorized refuge! quiet and serene. allows non motorized recreation: hikers, equestrians to enjoy the beautifull and peacefull quiet, views, in safety. Improves the habitat for the wildlife.
06/18/2014	I am concerned about the lack of supervision in the Teanaway Forest. I have emailed the DNR contact concerning these issues and he had indicated that there was no funding for a security person to enforce the rules. I have property on the Middle Fork and spend about four days a week there in the summer. I have done this for about 17 years. The man who was the security guard for the timber company, Gene McDonald, is my next door neighbor. I was very comfortable with the security all those years. If you talk to anyone they will tell you that Gene did a great job of taking care of the land and diffusing problems while at the same time keeping a friendly demeanor with everyone. But he was let go when the state took over last fall. Since then, I have experienced being nearly run over many times by motorcycles zooming down the trails, they have made deep ruts in the soft ground after the spring thaw that are now petrified in the dried mud and will serve as erosion channels when the fall rains come. This will gully out some of the dirt roads and trails they have impacted. The motorcycles are also a fire danger, running through the dried grass. It is for these reasons the timber companies have banned them from all their private lands. And the noise they make is very irritating to residents, recreation, and wildlife. You can hear them from miles away. I would hope that the word is not spread that no one is working at keeping them out of Teanaway and it is now open country for motorized vehicles. I have seen where 4 wheel drive vehicles are driving through the forest in order to get around gated roads. On memorial day weekend my friends and I who were riding our horses came upon a group of 7 of these vehicles filled with many people who were driving around one of the gates up off the west fork road not far from the turnaround. There were several motorcycles and a four wheeler too. The were all very unfriendly when they saw us. Later that afternoon and into the evening the sound of

	<p>semi automatic gunfire from the ridge sounded like a shooting range. I am wondering if they all spent the night up there having a big bash. On other week ends since then I have come upon people shooting big guns when I am out riding...it is scary, when they are shooting on a gated road below the one we were riding on and don't know if we will be hit by a stray bullet. One year a fire was started off the West Fork road the end of July and it was caused by people target practicing. The bullets can spark on rocks and the grass can smolder unnoticed for a day or two and the erupt into the trees. That is one of the reasons target practice is dangerous here. When I ride down along the West Fork river, near the turn around I have seen where people have driven 4 wheel drive vehicles across the river to get around gates. This is the first time in 17 years I have seen this. It just seems like a violation of the the river...a good way to introduce oil into the water. Also along that stretch of the river I have seen where people are building fire pits. The rules of the timber company which were strongly enforced by the security guard were no fires except in the campgrounds and after the dnr closes the area for fires in July there are to be no fires at all. I am worried that these fire pits will encourage others to build fires....and they will not even abide by the seasonal fire closures. Fire is our greatest danger. It will destroy the forest, river, residences and threaten the lives of the people who live there. This particular forest is at a higher risk of fire because the strong west wind that comes over Cle Elum ridge, the dry nature of the pine forest littered with needles, and the spruce bud worm damaging the trees. There is only one road to escape on and so it puts the residents at even greater danger than most places. It is for this reason mostly that I would strongly suggest that a security person be hired and make a big presence . Putting up signs is good, but Gene McDonald put up many and replaced them often as they were ripped down. Signs alone are not enough. A lot of money is being spent to encourage and accommodate more people to come to the new public forest. But the protection framework for the forest must be put in place before these people come. The timber company had a security guard to protect their asset. I don't think you need to pay for police protection with an armed guard. I think you just need to hire someone to keep an eye on things and enforce the rules and call the police or fire officers if there is a problem they cannot handle. Just knowing that someone was watching over the place seemed to keep illegal activity in check all these years. I know that Gene is still willing and able to do the job. I could not imagine that he would be so costly that there would be no money to pay him...I have no idea what he made, but it could not have been much and he would only need to be hired for the six months of snow free time. If you do not care to hire him, maybe someone else would do . But there does need to be someone there or it will become a free for all. As word spreads through social media that there is a great place for bonfires, parties and shooting, etc then it will be so much harder to control at a later date. And it may even burn down when the fire season comes. Then we will all lose. The rivers will suffer terribly and the whole point of the land purchase was to improve the rivers in the first place. We need to protect the asset from fire. It needs to be priority one, before any other work is done for roads, campgrounds, trails, signs, advertising, user groups, etc. Security needs to come first. The impact to the land, wildlife, and other non motorized users is very negative, unsafe, damaging to the land. I am a private land owner on the Teanaway Road, and will NOT allow motorized use! I am a equestrian rider quietly enjoying the amazing scenery and wildlife when I ride from Indian Camp Campground or park at West Fork Teanaway Road. 06/17/2014	On fencing the campground at 29 Pines to keep the cattle out, please install what I know as V pass throughs behind campsites that lead to the river. And think hard and fast if you put cattle guards at the entrance. Remember that people (Kids) ride bikes out of the campground and small kids may hesitate going over it and their leg goes through and at best gets a bruise or worse a broken leg results. I did some research on outhouses versus Composting toilets that are being considered in the campgrounds. First, most people have self contained toilets in Campers, trailers or motorhomes. The outhouses have a fiberglass tank and need to be pumped and have worked fine and have had no problems for 40 years. Composting toilets are very, very, costly and still need to be pumped. So, in time of cost saving even if money is appropriated does not have to be spent on toilets could be better spent on roads in 29 pines. The only way to fix the roads is to dig down a foot or more haul in large rip-rap and crushed rock with fines and pack it down. On the flip side, if you make a smooth roar then someone will be killed or hurt from a speeding car. Speeding is a problem now at the south end of 29 pines from the pump house to the last campsite at the south end. A few years ago a boy riding his bike coasted down from the south outhouse and came on to the road just south of the pump house, a speeding car hit the bike, the boy was fine but the bike was bent and the kids in the car shot off and headed into town. 06/17/2014	I'm writing to provide input regarding conservation and recreation in the Teanaway Community Forest. I'm extremely concerned about the 300 miles of illegal and unauthorized trails and roads that have been constructed in the Teanaway landscape, and feel very strongly that the vast majority of the trails should be closed and rehabilitated. The recreation plan should also ensure sufficient funds are available for monitoring and enforcement any areas open to motorized recreation, since motorized recreation users have a penchant for straying off authorized routes – illegal activity should be punished to the fullest extent of the law. The area is also used as an access by snowmobilers into federal lands including Wilderness, so I'd like to see these areas of access closed and resources made available for monitoring and enforcement of closures. The Teanaway is also home to important spotted owl nest sites and serves as the headwaters to key trout and salmon habitat. I'd like the community forest to focus on restoring older forest conditions, especially large old trees, snags and down logs. To improve aquatic habitat and improve elk security, the road network will need to be reduced significantly, including reducing stream crossings and reducing road density below 1 mile per square mile. The activities I enjoy and would like to continue to enjoy in the Teanaway Community Forest are hiking, camping, skiing and wildlife watching. I prefer non-motorized recreation and would find the area more enjoyable if motorized activity were restricted or eliminated from the area. They've had their time there, abused their privilege, and should face consequences.
06/17/2014	Is this going to be another off-road park? If so, awesome!! Need more places up north though. Going south costs too much. And since Reiter got closed walker valley has been the only place and it's getting boring, I can drive through there in two wheel drive and with my eyes closed.

➤ **Goal 4: Conserve and restore vital habitat for fish, including steelhead, spring chinook, and bull trout, and wildlife, including deer, elk, large predators, and spotted owls; and (9 Comments)**

7/1/2014	The Teanaway Community Forest is important wildlife habitat, especially in winter, because of its relatively low elevation and south-facing exposure. It adjoins the Alpine Lakes area where we have known populations of elk and a wolf pack, and which is part of the North Cascades Grizzly Recovery Area. One of the last confirmed sightings of a grizzly in the Cascades was in the Teanaway. Wolves and grizzlies are both endangered species under federal and state law. As state land, the Teanaway Community Forest should be managed to improve their chances of recovery. Because ORVs and ATVs are notoriously hard on wildlife they should be excluded from the Teanaway Community Forest. I don't think snowmobiles bother grizzlies during their hibernation, but they're tough on

	ungulates and the wolves that depend on ungulates throughout the winter. When the Interagency Grizzly Bear Committee was considering the North Cascades as a candidate recovery area, one of their chief concerns was the lack of spring range that was not occupied by humans. The Teanaway is one of the few places in the Cascades that provide this spring range. For that reason alone, the Community Forest is critical to wildlife and should be managed for their sake. .
06/28/2014	The Teanaway Community Forest provides important habitat for elk, wolves, spotted owls, as well as salmon, trout and steelhead. It was purchased to safeguard the basin's water supply and restore critical fish and wildlife habitat while providing for recreation activities. When I attempted to retrieve the camera on 4/18 there was a note where the camera was that said "private property" and the camera was gone. I was able to determine whose property this was by taking the GPS location and contacting the Kittitas County Assessor's office. I am writing to find out if you or perhaps the person who has the cameras would be willing to relinquish it. I would be glad to send a check to cover the postage or make any other arrangements that would be convenient for you so I can get my camera back.

	<p>I did not intentionally trespass on your property and I have always been very careful about property rights. I can certainly understand the frustration you must feel when you have such a lovely and secluded area you want for your privacy and someone trespasses on it. The following is how I ended up on your property. On 4/5 I parked my car at the gate where Teanaway Road and the Storm Creek Road intersect. I walked north on Storm Creek Road about half a mile and then veered east and began hiking cross country. After hiking about a mile I found a great place to put up my game camera, which is an intersection between two roads that clearly had had many animals walking on the roads. After I placed the camera I continued to hike cross country and on my return I hiked back to my car the same way I came. During the past two years I have spent close to 21 days hiking and camping in The Teanaway. I do not hunt and only wanted to use the game camera to see what animals I could take pictures of. On 4/18 I returned to pick up the cameras and followed almost exactly the original route I had made. Neither time while I was hiking did I run into any trespassing signs? Before I took this journey I even looked at the Teanaway Community Forest map and this did not, unfortunately, as far as I could see, show your private property. The Kittitas County Assessor map shows you own section 32, T.21n R. 16 E and after reviewing the map I now have a very good idea where your property lies and I can promise you I will no longer trespass on your land.
