

# ***SPECIAL FOREST PRODUCTS PERMIT APPLICATION***

## **- INSTRUCTIONS -**

*One permit application and payment per person.*

*Each individual picker is required to possess their own permit.*

***PERMIT SALE DATES: JANUARY 3, 2023 – SEPTEMBER 30, 2023***

a) Fully complete each section, including appropriate check boxes, and provide all information as required. All applications which are incomplete, illegible, or contain the incorrect payment amount and/or type will be rejected and returned to the applicant along with any payment received. (Complete completamente cada sección, incluidas las casillas de verificación apropiadas, y proporcione toda la información según sea necesario. b) Complete, sign and date the application and mail it along with the correct permit fee/payment type and a copy of the Permittee's photo identification to the South Puget Sound Region Office in Enumclaw (*Completar, firmar y fechar la solicitud y enviela por correo junto con la tarifa de permiso/tipo de pago correcta y una copia de la identificación con foto del Titular a la Oficina de la Región Sonora de Puget Sur en Enumclaw*):

c) Special Forest Product Permit fees are as follows:

Brush: \$600

Mushrooms: \$400

Combination Brush and Mushrooms: \$800

d) Permit fees must be paid **with a cashier's check or money order. No other forms of payment, including cash or personal checks, will be accepted.** (*Los cargos por permiso deben ser pagados con un cheque de caja o giro postal. e) Two vehicles may be authorized on each permit, Sections 13-17 are required; Sections 18-22 are optional. (*Se pueden autorizar dos vehículos en cada permiso, se requieren las secciones 13-17; Las secciones 18-22 son opcionales.*)

f) **Once the completed application and payment has been processed, a Specialized Forest Products Harvesting Permit, harvest area map, Permit Conditions sheet, County hauling permit, vehicle windshield placard, and a receipt will be mailed back to the Permittee at the address listed on the application.** Application processing time will be up to ten (10) business days from the time the application and payment are received. If you have not received a valid permit after ten (10) business days, please contact the South Puget Sound Region Office at 360-825-1631. **It is the Permittee's responsibility to promptly sign and date both the Brush Harvesting Permit and Hauling Permit, which are not valid unless signed and dated.** (*Es responsabilidad del Permiso firmar y fechar sin demora tanto el Permiso de recolección del cepillo como el Permiso de acarreo, que no son válidos a menos que estén firmados y fechados.*)
