- 1. Both tare weight and live load weight must be printed on each ticket. (Tare weight is the weight of the unloaded truck; live load weight is the weight of the loaded truck) Average tare weight may be used if approved by the State. If average tare weight is approved by the state a new tare must be established each month.
- 2. Pups and mule train loads are treated as separate loads.



DATA TRANSMISSION

This contract requires the use of a State approved third party Log and Load Reporting Service (LLRS). Purchaser shall ensure log weight data is received by the LLRS within 1 business day of logs being weighed.
